These give useful and detailed admission statistics that are not all available online. They include information about the number of applicants, offers and places for each course, so that pupils can make better decisions on their UCAS application forms. They also give information about the most popular courses at each university and which take part in clearing. The Oxford and Cambridge Admission statistics gives detailed information about applicants for each college and course, as well as the predicted and achieved grades of their candidates.

UK University applications

Change continues to be the only constant in the world of university admissions. The turmoil from A Level and IB results has meant there are a number of students who have been forced to defer their places to September 2021, and this may have an impact on how many students some of the smaller and more competitive universities can take next year. The change in fee status for EU students in the UK may result in a lower number of EU applications this cycle and a continuation of coronavirus may impact applications from international students. This all makes it harder to plan application strategies for the 2020-21 cycle. The advice from UCAS and the universities is to continue as you normally would with choices and applications. Choosing the right course and the right university are still the key drivers for decision making. London Universities, especially King's, UCL, Imperial and LSE, continue to be very competitive largely due to their attractiveness to international students. We encourage pupils to look further afield than just London or to consider Queen Mary and Royal Holloway (both part of the University of London) as alternatives.

With some lack of transparency regarding the grades UK universities officially require for each course, and the grades that they actually accept, we have carried out detailed research to help pupils make better informed decisions. We have admissions information for many of the top universities – the number of applicants, places offered and places accepted for every course. This has been useful to gauge the popularity of courses and advise pupils accordingly. Given that the top 10 courses at many universities account for over 40% of applications, it is sometimes worth applying to a very similar but much less popular course in terms of applications. What is more difficult to establish is the actual (lowest) grades a university has accepted an applicant onto a course. We know that many universities are flexible on their entry requirements so we can advise pupils on sensible insurance choices.

We offer sessions every day for any 2YS to discuss their UCAS applications and we aim to meet with every 2YS before they submit their UCAS application to make sure they have made sensible choices. Applying to Oxford and Cambridge

Georgia Galton Ayling has joined the HE department as our new Oxbridge Coordinator and HE advisor. After studying English Literature and Language at Christ Church College, Oxford, she





completed her PGCE through the Teach First Programme. As well as teaching English, she will be supporting all 1YS and 2YS through their Oxbridge applications.

We now have a list of 2YS who intend to apply to Oxford and Cambridge. For those subject that require tests, they are on 4th and 5th November. These pupils had a talk this week about the application process and both universities have virtual open days which give pupils an opportunity to learn more about different colleges and departments.

Oxbridge Reading Lists

Advice for applicants to prepare for interviews: Strong applicants to Cambridge and other competitive universities tend to have explored their chosen subject through wider reading outside the classroom, as well as doing very well in their GCSEs and A-levels. We call this sort of exploration 'super-curricular', as it builds on and enhances what you are studying in school. This selection of suggested reading lists and resources has been gathered from the Cambridge departmental and College websites, other universities and other sources on the internet. These lists are certainly NOT 'required reading' for Cambridge applicants. It is important to read critically, thinking carefully about the arguments, assumptions and evidence presented by the author. Reading is a great way to explore subjects that you find interesting – but there are many other ways to deepen your understanding: investigate your local museums, monuments, galleries and natural features, and think analytically about nature, machinery or the built environment. The best thing about super-curricular activities is that there are no exams or deadlines to worry about – you are free to follow your own lines of enquiry into the areas that interest you the most. Oxford University Admissions Feedback

We thought it might also be interesting to share some of the feedback from the latest 2019/20 admissions cycle at Oxford University. The information below is for PPE at Keble College, but we have subject admissions reports for other courses available if you are interested.

PPE: Oxford had more applicants for PPE than last year as shown in the following figures (2018/19 in brackets):

Total applicants: 2224 (2338) Not invited to interview: 1487 (1604) or 67%

Interviewed in Oxford (or remotely): 737 (719)

Expected offers 2019-20: 240 (276)

Approx. ratio of applicants to offers 9.3 (8.5) PE

Decision to call for interview

Because there are so many applicants, and only two or three days in which to conduct the interviews, not all applicants can be shortlisted. Only around one third of applicants were shortlisted this year. We make these decisions based on: UCAS information about past and predicted exam results; UCAS academic reference; and the result of the Thinking Skills Assessment test (TSA Oxford) — a two-hour test involving multiple-choice reasoning questions and an essay.

Candidates who score well in the TSA (above 73.26 this year) and had good exam results and references were likely to be asked for interview. Candidates who scored between 73.25 and 70.45 may have been invited for interview. Candidates scoring below 70.45 will only have been invited for interview with special consideration of other factors, including contextual information. Reallocation between colleges Applications to colleges for PPE vary every year and colleges have varying numbers of places to offer. Where a college has a large number of shortlisted candidates relative to its places there is a process by which candidates are reallocated to colleges with lower ratios of shortlisted candidates to places. Candidates selected for reallocation are those for whom information available at the shortlisting stage suggests the chance of acceptance can be improved by reallocation. This year, several applicants were allocated to Keble from other colleges in this way Criteria for admission We seek highly motivated students with a strong interest and potential in PPE. Specific knowledge of the three subjects in PPE is not required either for the interview or for admission to PPE. Mathematics A-level is extremely helpful for understanding the material we teach once admitted and the vast majority of students with A-levels that we admit have this subject. We are open to overseas applicants who are assessed on exactly the same basis as domestic candidates.

Keble College admits eight students a year to study PPE. There were 62 applicants to Keble this year and we interviewed 21 candidates, including several reallocated to Keble from other colleges. Generally, colleges interview about 2.75 candidates for each offer made, so that candidates at interview have just over a one in three chance of being offered a place. Keble made seven offers for admission to the college and 1 open offer for a place at Oxford at a different college.

Applying to study Law

William Baugniet (WRB) supports pupils who are considering studying law at University. He runs workshops for 1YS in CQ and supports 2YS with their applications. 2YS have a link to a Zoom workshop on drafting a personal statement for an application to study law at university on Greyhound. They also have two documents showing the list of what to put on a Law personal statement and examples of what a good personal statement looks like.

The Law Society runs interesting lectures and has a very active programme of events this term, starting with a Lecture on 21st September by Mr Michael Mansfield QC

Pupils need to keep up to speed with news and current affairs, debates in Parliament and significant judgments reported on in the press. Make a note of any specific case or news item with a legal dimension, which you have found thought-provoking because it raises ethical, philosophical, political and legal issues.

All 2YS interested in Medicine and related degrees have now met with Mr Bagley (PAB) to discuss the application process this Quarter. The pupils will now put together details of their UCAT test scores, their draft UCAS predictions, upload their personal statement, use the self-review tool and upload the standard information onto UCAS. The pupils 'collaborative reference writing tool will help coordinate the content of their personal statement and school reference with the medical school's admission criteria.

Up until leave weekend, the focus will be on finalising applications. Mr Bagley or Dr Warren will review personal statements and meet individually with candidates to discuss and finalise medical school choices and the 'fifth choice' of a non-medical course. Choosing schools is a tactical affair, matching relative strengths in IGCSEs, UCAT, predictions and personal statement with the medical school's selection process. For example, a pupil with an exceptional high UCAT score would be advised to apply to a school that uses UCAT almost exclusively for interview selection.

October: After leave weekend, we will be running BMAT sessions with practice papers but principally focusing on technique for the essay question. Scientists can struggle with this and some simple techniques can make all the difference. On 8th October, we have arranged for the University of Nottingham to run an introductory session for our pupils on interview training (the format of this may change to on-line depending on the COVID situation). This then leads into our interview training. We are planning a fully mocked up MMI and situational judgement training in conjunction with St Catherine's school Bramley and panel style mocks in Charterhouse. We will be revisiting the format of these to take account what current regulations allow, and how the universities themselves will be running their own interviews. The interview practice gives constructive feedback both on the pupils' performances and on their level of knowledge of medical matters, for example the structure of the NHS.

December - March There then follows a long period when pupils may be interviewed. Typically pupils will meet Mr Bagley or Dr Warren shortly before their interview to finalise their preparation.


1YS: The 1YS process starts with an introductory session by the University of Nottingham on 8 October which anyone who thinks they might apply to Medicine, Veterinary or Dentistry should attend. Pupils will then need to arrange work experience (and alternatives in the current environment), read, join the Medics Society and do anything else to help them decide whether or not medicine is right for them.

We will have a talk for all pupils and parents in LQ to run through the process for medical applications. There is quite a lot to consider and it is helpful to have plenty of time to prepare.

Charterhouse Leavers 2020

We thought it would be interesting to share information regarding the destinations of last year's 2YS, many of whom are starting university this Autumn. 205 pupils applied to UCAS (including 10 OC's) in the 2019/20 admissions cycle. The three most popular universities for applications were Kings (82), UCL (82) and Edinburgh (67). The three universities that gave the most offers to our pupils were Exeter (60), King's (58) and Bristol (49).

Applications to US Universities

We have an extensive programme of events to prepare pupils for applications to American Universities. Our USA applications counsellor, Dr Loni Reynolds, will be working with Charterhouse on Tuesdays and Thursdays this term, 12:30-6:30pm (Tuesdays remotely and Thursdays in person, in the Careers office).



2YS: If you are NOT using an external advisor, these must be drafted by **5**th **October** to allow Dr Reynolds the time to process them. In order to apply to the US, the school must submit documents on your behalf. So, even if you are working with an external counsellor, our Careers office must be aware that you are applying to the US. Additionally, you must do a few things and communicate with us, your housemaster, and the teachers from whom you want references.

Key dates:

1st October: Notify the Careers office if you are applying Early Action or Early Decision and make sure you've done all the tasks on the template sent to pupils.

1st November: Early application submission deadline

6th November: Regular decision documents deadline

11th December: School closes- last day Careers can submit documents on your behalf or answer queries

1st January: Regular decision submission deadline

1YS interested in applying to the US have now signed up for UES's SAT/ACT course which starts on 20 September. The course will aim to prepare students for a first sitting of the test on 5 December for the SAT and 16-17 April for the ACT.
